LENA SAID THE ROAD CALLED "GRANDMA DRIVE" WAS BUILT AS A DRIVEWAY AND WAS EXPANDED WITHOUT BORE SAMPLES OR DNR APPROVAL. THIS ROAD LEADS THREW A WETLAND AREA. THIS ROAD IS OWNED BY BOARD SUPERVISOR TED DREMEL. DREMEL IS IN THE PROCESS OF DEVELOPING A SUB-DIVISION AND GRANDMA DRIVE WILL BE THE ACCESS ROAD. LENA CLAIMS THAT DREMEL HAS USED HIS POSITION ON THE TOWN BOARD TO DENY OTHER DEVELOPMENTS IN THE KANSASVILLE AREA AND PROMOTE HIS OWN.

MIKE CIECKO SAID THAT HIS PERMITS FOR BUILDING STORAGE SHEDS ON HIS PROPERTY ARE BEING HELD UP BY THE TOWN BOARD. CIECKO SAID THE MINUTES OF DOVER TOWN MEETING 9-15-99 STATE HE WILL ACCEPT THE DRAINAGE TILE PLAN FROM GRANDMA DRIVE. CIECKO CONTENTS THAT HIS PROPERTY DRAINS TO THE NORTH AND WILL NOT AFFECT THE WETLAND.

RACINE CO PLANING/ZONING OFFICE HAS APPROVED THE CIECKO PLANS. JULIE ANDERSON SAID THE DRAINAGE ISSUE IS THE TOWN OF DOVER'S TO DECIDE. THE COUNTY IS OUT OF THIS PER ANDERSEN.
